

CLUB MEMBERSHIP RELEASE FORM FOR ADULTS

The undersigned (on my own behalf of my heirs, personal representatives, successors and assigns), for and in consideration of the opportunity to participate in a "Ride," "Rally," "Field Meet," "Meeting," or "Activity" (hereinafter, **EVENT(S)** sponsored and/or conducted by Rolling Iron Riders Club, LLC and their respective officers, directors, founders, Ride Leaders and agents (hereinafter the "**RELEASED PARTIES**") releases and holds harmless the "**RELEASED PARTIES**" from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the "**RELEASED PARTIES**" in any way resulting from, arising out of, or in connection with the performance of their club duties and my participation in any said **EVENT(S)**.

This Release extends to any and all claims I have or later may have against the "**RELEASED PARTIES**" resulting from or arising out of their performance of their club duties whether or not such claims result from negligence (except willful neglect) on the part of any of the "**RELEASED PARTIES**" with respect to the **EVENT(S)** or respect to conditions, qualifications, instructions, rules or procedures under which **EVENT(S)** are conducted or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL THE "**RELEASED PARTIES**" FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH, THE PERFORMANCE OF THEIR CLUB DUTIES IN SPONSORING, PLANNING, OR CONDUCTING THE EVENTS.

I certify that if I operate a motorcycle, I am properly licensed and insured in the operation of that motorcycle in the State of my residence. I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I'm voluntarily participating in the **EVENT(S)** and **I expressly agree to assume the entire risk** of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the events, and any negligence (except with willful neglect) on the part of any or all the the "**RELEASED PARTIES**" in performing their club duties.

WAIVER OF RIGHTS UNDER STATE STATUTES

I further agree to waive all benefits flowing from state statues which would negate or limit the scope of this Release and Indemnification Agreement.
